The BC Achievement 2021 Community Awards

Mayor Leclerc acknowledged Nirmal Parmar for receiving a 2021 Community Award. The BC Achievement Community Award recognizes the contributions of extraordinary British Columbians who build better, stronger, more resilient communities and shine as examples of dedication and service.

DELEGATIONS & GUESTS:

Anna Glass, Terrace and District Museum Society – Mandate Changes Mayor Leclerc welcomed Ms. Glass, curator for the Terrace and District Museum Society, to the Council meeting. Ms. Glass presented a proposal for a mandate change that would also impact the Terrace and District Museum Society's constitution.

The current mandate of the Terrace & District Museum Society is:

- A. HERITAGE PARK: To maintain, preserve, operate, and promote the premises, facilities, and archives of Heritage Park as an interpretive site representing the settlement era in the region from 1890 to 1930;
- B. MUSEUM: To establish a dedicated museum and archives and, in so doing, identify, collect, preserve, and display artifacts and documents from time immemorial to the present for Terrace and the surrounding area.

They proposed changing the mandate to:

A. HERITAGE PARK MUSEUM: To maintain, preserve, operate, and promote the premises, facilities, and archives of Heritage Park Museum as an interpretive site and museum representing the region up to the year 1950.

The Terrace and District Museum Society Board has sanctioned all the proposed changes to the mandate.

These changes will allow the inclusion of First Nations cultures in the region and expand the time period in their mandate, while removing the downtown museum from the mandate.

The Terrace and District Museum Society's mandate is presented when applying for grants. The Board wanted to remove the wording around establishing a museum so that it would be understood that they are a museum.

Terrace needs a facility that properly archives items that cover the broad spectrum of cultures in our region. There were concerns expressed with regards to hindering the possibility of getting a proper building to display and store artifacts by expressing that they were already a museum.

The Terrace and District Museum Society does not have adequate storage or the ability to properly house climate-controlled artifacts. Other than that, they are a museum.

Mayor Leclerc thanked Ms. Glass for her presentation and advised that the matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (See Resolution No. 205).

3. DEVELOPMENT PERMIT NO. 08-2021 - ROYAL CANADIAN LEGION TERRACE BRANCH 13 (4425 LEGION AVENUE)

It was recommended that Council issue Development Permit No. 08-2021 to the Royal Canadian Legion Terrace, Branch 13, for the property legally described as: Lot 9, Block 2, District Lot 369, Range 5, Coast District, Plan 3094 (4425 Legion Avenue) to permit the development of a covered and enclosed patio on the south side of the Legion hall building, including the following variances:

➤ To vary Table 3 of Section 8.2.1 of Zoning Bylaw No. 2069-2014 to not require a minimum number of off-street parking spaces as required for a pub and restaurant but to allow the existing parking to remain as is;

- ➤ To vary Section 8.4 of Zoning Bylaw No. 2069-2014 to not require the off-street parking standards but allow the parking and loading area to remain in its present condition; and
- > To vary the landscape requirements in Section 5.1 of Zoning Bylaw No. 2069-2014 to not require any new landscaping installations.

- 1. As an exception to section 110 of the Act, and despite sections 6.0 (a) and (b) of the "Election and other Voting Procedures Bylaw No. 1329- 1993" as amended, or an applicable provision of any other bylaw, Council may, by resolution permit voting by all eligible electors under the Act to be done by mail ballot and, in relation to this, may permit elector registration to be done in conjunction with this voting.
- 2. As an exception to section 125 9(1)(b)(c) and (2) (a) of the Act, or an applicable provision of any bylaw, Council may, for the City of Terrace by-election, by resolution permit the elector, as directed by the election official responsible, to make an oral declaration that the elector is entitled to vote in the by-

- election when obtaining a ballot for voting, in which case the election official responsible must make a record that the elector made an oral declaration.
- 3. As an exception to section 109 (1) of the Act, and despite section 5. 0 of the "Election and Other Voting Procedures Bylaw No. 1329-1993" as amended, or an applicable provision of any other bylaw, Council may, for the City of Terrace by-election, by resolution permit the City of Terrace's Chief Election Officer to establish special voting opportunities or determine that no special voting opportunities will be held at their sole discretion.
