Yvonne Moen, 100th Anniversary of the Terrace Townsite Yvonne Moen thanked Council for the opportunity to present. She has discovered that the Terrace townsite was surveyed in 1911, and that the former Terrace Hotel and the first sawmill in Terrace were both built 100 years ago. As Heritage Month is in February Ms. Moen suggested that would be a good time to celebrate the 100th year of the Terrace townsite. This year's theme for Heritage Month is "Parks and Cultural Landscapes" and City Planner David Block pointed out on the original survey where George Little Park, the Sportsplex and Aquatic Centre are now located.

Ms. Moen suggested that the Riverboat Days Committee might be interested in making this their theme for 2011 and traditional events such as tug-of-war, Maypole dancing and football could be held in George Little Park.

Mayor Pernarowski thanked Ms. Moen for her presentation, and advised that this matter would be further dealt with under the "Correspondence" portion of this meeting's Agenda (see Resolution No. 007).

Lorna Brown, Request for Support for the 2012 North American Indigenous Championship Games Lorna Brown thanked Council for the opportunity to present. She gave some background on the North American Indigenous Championship Games. The opportunity to host some or all of the 2012 Championship Games has come up for bid throughout North America. Ms. Brown is part of a newly-formed group in the Northwest who are preparing a bid to host four sports: soccer, basketball, canoeing and 3D archery. Ms. Brown has talked to local organizers of these sports and received their support. The District of Kitimat will be invited to co-host the event.

The Championship Games would be held sometime between June 29, 2012 and August 19, 2012. Kitsumkalum First Nation would make the bid and be the official host community.

Ms. Brown requested support from the City of Terrace through the use of facilities, particularly the soccer fields, and a letter of support. Should their bid be successful, Ms. Brown indicated she would be approaching Council to request financial support but was uncertain at this time of the amount of the request.
