#### 1. DEVELOPMENT VARIANCE PERMIT 21-2015 PRIORITY PERMITS LTD. (4736 LAKELSE AVENUE)

It is recommended that the City issue Development Variance Permit No. 21-2015 for the property located at 4736 Lakelse Avenue (Lot A, District Lot 361, Range 5, Coast District, Plan 10830), including the following variances:

- ➤ To vary Section 1.0 Definitions of Sign Bylaw No. 1500-1996 and amendments thereto, to increase the maximum height of a Ground Sign from 3 metres to 3.05 metres;
