“A BYLAW OF THE CITY OF TERRACE CONCERNING ESTABLISHMENT OF FEES AND CHARGES FOR PARKS, RECREATION, AND CULTURAL SERVICES.”

WHEREAS pursuant to the Community Charter, a Council may, by Bylaw, impose a fee payable in respect to all or part of a service of the municipality, the use of municipal property, or the exercise of authority to regulate, prohibit or impose requirements;

AND WHEREAS the Council of the City of Terrace wishes to set fees and charges for the use of, or admission to, certain recreation, parks and cultural services and facilities; and

NOW THEREFORE the Council of the City of Terrace in open meeting assembled, hereby enacts as follows:

1.0 TITLE

1.1 This bylaw may be cited as the “Parks, Recreation & Culture Fees and Charges Bylaw”

3.0 DEFINITIONS

#2317-2025

In this Bylaw:

- 3.1 **“Adult”** means nineteen to fifty-nine (19-59) years of age.
- 3.2 **“After Hours”** means any time when recreation facilities are not open to the general public.
- 3.3 **“Bulk Membership”** means memberships purchased in amounts exceeding \$1000 by a company, organization or group.
- 3.4 **“Child”** means three to twelve (3-12) years of age.
- 3.5 **“City”** means the City of Terrace.
- 3.6 **“Commercial”** means any individual, company or organization carrying on an activity in City of Terrace facilities for the purpose of generating a profit, excluding not-for profit fundraising.
- 3.7 **“Council”** means the Council of the City of Terrace.
- 3.8 **“Facility”** means any Parks and Recreation building, or other land improvement, including, but not limited to, the Sportsplex, Terrace and District Aquatic Centre, arenas, parks, sports fields, ball diamonds, picnic shelters, parking lots, and other recreation facilities located on any land which the City owns or controls by means of a lease, licence, or other legal instrument, that is intended for recreational, social or cultural use by members of the community.
- 3.9 **“Facility Use Permit”** means a permit issued pursuant to this bylaw for the use of a recreation facility, or portion thereof.

- 3.10 **“Family”** means members of an immediate family. Maximum of two (2) adults (+19 years of age) and up to three (3) children/youth who are immediate family members living in the same household. Foster children and other dependent minor children living in the family are included.
- 3.11 **“High-Risk Event”** means an event such as, but not limited to, circuses, festivals, large community gatherings, parades, beer gardens, and events involving liquor licences and motorized activities.
- 3.12 **“Infant/toddler”** means under three (3) years of age.
- 3.13 **“Low-Risk Event”** means any rental event which does not fall under the “high-risk event” definition.
- 3.14 **“Non-Profit Adult Group”** means a registered non-profit organization that primarily provides services for individuals nineteen (+19) years of age and over.
- 3.15 **“Non-Profit Youth Group”** means a registered non-profit organization that primarily provides services for individuals under nineteen (19) years of age.
- 3.16 **“Northwest Trades & Employment Centre Gym”** means the Coast Mountain School District #82 gym located at 3120 Highway 16 East, Terrace, British Columbia.
- 3.17 **“Park and Public Places Bylaw”** means the City of Terrace’s current Park and Public Places Bylaw.
- 3.18 **“Per Day Rental”** means a 24-hour rental period.
- 3.19 **“Regular Ice Season”** means the period of October 1 – March 31.
- 3.20 **“Renter(s)”** means the individual(s) or User Group(s) responsible for the booking, payment, and supervision of the rental agreement/booking.
- 3.21 **“Senior”** means sixty (+60) years of age and over.
- 3.22 **“Off-Season Ice”** means the period in which the ice surface is in the arena(s) at the Sportsplex during April 1 – September 30.
- 3.23 **“Sportsplex”** means the City of Terrace facility located at 3320 Kalum Street, Terrace, British Columbia that consists of the Main and Hidber Arenas, Banquet Room, Rich McDaniel Conference Room, Multipurpose rooms and the City of Terrace Parks, Recreation & Culture administration offices.
- 3.24 **“SOCAN”** means the Society of Composers, Authors, and Music Publishers of Canada.

- 3.25 **“Terrace and District Aquatic Center (TDAC)”** means the City of Terrace Aquatic Centre located at 4540 Park Avenue, Terrace, British Columbia.
- 3.26 **“Tournament”** means a series of games played by multiple teams over three (3) or more days to a maximum of five (5) days.
- 3.27 **“User Group”** means a group or organization that is issued a Facility Use Permit for renting the facility. This may include one-time rentals, school groups, regularly scheduled sports teams, etc.
- 3.28 **“Youth”** means thirteen to eighteen (13 - 18) years of age.

4.0 GENERAL CONDITIONS FOR RENTAL OF FACILITIES

- 4.1 All rental rates and fees are subject to the Goods and Services Tax (GST) and Provincial Sales Tax (PST) where applicable.
- 4.2 No City-owned facility or premise shall be rented to a minor [under nineteen (19) years of age].
- 4.3 Where there is an established rental fee, no user group or renter will be entitled to facility use without charge, except with prior written agreement, as per City of Terrace Waiver of Rental Fees Policy No. 36.
- Amended by #2317-2025 4.4 All facility rental fees must be paid a minimum of thirty (30) days in advance of the booking. For bookings made within thirty (30) days of the facility rental date the rental fees must be paid at the time of booking.
- 4.5 All rental rates include the standard facility, with normal operating or maintenance staff. Use beyond normal operating hours (after hours) will require payment of additional labour costs.
- 4.6 The City of Terrace reserves the right to require a damage deposit for rentals.
- 4.7 The Renter must pay the damage deposit charge at the time of booking.
- 4.8 The Renter will be responsible for any damages caused during or as a result of their use of any City Facility or premises, and the percentage of deposit returned will be based on additional staff time required for clean up or repair of damages.
- 4.9 Services such as ticket sellers, security, etc., are the responsibility of the Renter or User Group.

- 4.10 *Facility rules and regulations are to be strictly adhered to. Failure to adhere to or comply with the rules and regulations may result in the termination of usage without refund of any rental fees paid and may include invoicing of penalties of costs incurred by the City.*
- 4.11 *Prior to use of any facilities, the Renter must execute a Facility Usage Agreement. This document includes a waiver or release which must be read by the Renter before signing.*
- 4.12 *Early entry to rented facilities for decorating, set up, etc., will be subject to available Facility staff and Facility availability. Additional fees, charges, and conditions may apply.*
- 4.13 *Facility rentals include chairs, tables and other items associated with each room, such as projectors and sound systems.*
- 4.14 *The event must not exceed the maximum capacity limit allowed for the facility. See Section 10.0 for capacity limits.*
- 4.15 *Liquor is not permitted on any City of Terrace premises unless a liquor permit is obtained and/or in effect. The Renter must obtain a Liquor Special Event Permit or Liquor Charitable Auction Permit from the Liquor and Cannabis Regulation Branch (LCRB). Liquor Permits must be visibly posted at the premises in which Liquor will be served and/or consumed and a copy of the Liquor Permit must be submitted to the City or hosting body prior to the event.*
- 4.16 *The Renter is responsible to ensure that the facility is vacated at the end of the event. The Renter will ensure all personal belongings and equipment are removed from the City building, facility, or premise after each use. The City and its staff assume no responsibility for the loss or damage of personal items.*
- 4.17 *The Renter is responsible for ensuring that clean up and refuse removal takes place in and around any building, facility, or premise immediately after the activity and/or event is complete.*
- 4.18 *Standard sound system is available in the Sportsplex Banquet Room, the Rich McDaniel Room, the Hidber and Main Arenas, and in the main pool of the Aquatic Centre.*
- 4.19 *Subletting of rental dates, times, or space is not permitted. Renters found to be subletting their space will be charged an administrative fee, and future bookings may be cancelled.*
- 4.20 *Permits are provided electronically to the email address provided. A single copy of the permit can be printed upon request.*

5.0 Facility User Insurance Requirements

- 5.1 *All Renters for special/sporting events, conferences, and trade shows must have an insurance policy not less than \$3 million dollars. If the event is deemed high-risk, such as over 500 people in attendance or alcohol being served, \$5 million dollar liability insurance is required. Liability insurance requirements apply to all City of Terrace facilities, field and park events and Northwest Trades & Employment Centre Gym Rentals.*
- 5.2 *The insurance policy must include liability limits with respect to bodily injury, death, and property damage. The policy must list the City of Terrace, Coast Mountain School District #82 or the Regional District of Kitimat-Stikine as additional named insured, depending on facility/field being rented.*
- 5.3 *A copy of insurance must be provided to City of Terrace Parks, Recreation and Culture a minimum of 10 days prior to the event. Insurance can be secured through a local broker.*
- 5.4 *Facility user groups who are hosting special events or games are responsible for providing sufficient security to provide a safe environment for participants and the public in attendance at the event.*

6.0 COAST MOUNTAIN SCHOOL DISTRICT #82 JOINT USE AGREEMENT

- 6.1 *The City of Terrace Parks, Recreation & Culture Department has a reciprocal use agreement with Coast Mountain School District #82. All School District #82 facility use shall be in accordance with the School District #82/City of Terrace Joint Use Agreement.*
- a) *Despite this agreement, the City of Terrace reserves the right to charge a Cancellation Fee for Coast Mountain School District #82 school groups that fail to attend their rental/booking.*

7.0 REFUND AND CANCELLATION POLICIES

7.1 SWIMMING LESSONS AND SWIMMING COURSES

- a) *Registrants who provide more than seven (7) days' notice of withdrawal to the start date of the swimming lesson/course, will receive a full refund to their original payment method or account credit, minus an administration fee.*
- b) *Registrants who withdraw with less than seven (7) days' notice to the start date of the swimming lesson/course, will receive 50% of the registration fee to their original payment method or account credit, unless space can be filled from a waiting list, then a full refund will be issued, minus an administration fee.*
- c) *Enrollment fees will not be returned to registrants wishing to withdraw after the commencement of the swimming lesson/course.*

- d) *Transfer requests made with more than seven (7) days' notice to the start date of an swimming lesson/course, will be subject to open availability. An administration fee will be charged.*
- e) *Transfer requests made with less than seven (7) days' notice to the start date of the swimming lesson/course, will be subject to availability, considered on a case-by-case basis, and are not guaranteed to be accommodated. An administration fee will be charged.*

7.2 **RECREATION PROGRAMS, ACTIVITIES AND COURSES**

- a) *Registrants who provide more than seven (7) days' notice of withdrawal to the start date of the program/activity/course, will receive a full refund to their original payment method or account credit, minus an administration fee.*
- b) *Registrants who withdraw with less than seven (7) days' notice to the start date of the program/activity/course, will receive 50% of the registration fee to their original payment method or account credit, unless space can be filled from a waiting list, then a full refund will be issued, minus an administration fee.*
- c) *Enrollment fees will not be returned to registrants wishing to withdraw after the commencement of the program/activity/course.*
- d) *Transfer requests made with more than seven (7) days' notice to the start date of an program/activity/course will be subject to open availability. An administration fee will be charged.*
- e) *Transfer requests made with less than seven (7) days' notice to the start date of the program/activity/course will be subject to availability, considered on a case-by-case basis, and are not guaranteed to be accommodated. An administration fee will be charged.*

7.3 **RECREATION MEMBERSHIPS**

- a) *Membership sales are non-refundable and non-transferrable.*
- b) *Membership expiry dates will be automatically extended in the event of facility closures, such as the annual Terrace and District Aquatic Center shutdown. Membership expiry dates will not be extended for temporary closures (one day) or maintenance of facility equipment.*
- c) *Membership holders moving more than 45 kilometres from the City of Terrace may request a refund of their membership. Proof of this move is required, and refundable fees will be subject to approval and will result in a prorated refund.*
- d) **Pausing of memberships is permitted with limit on total limitations (no medical note required).**
 - *Any (1) month membership can be paused by member, for up to a 1 week, one time during membership.*
 - *Any (3) month membership can be paused for up to 2 weeks, up to two times during a membership.*
 - *Any (6) month membership can be paused for up to 2 weeks, up to four times during a membership*

- Any 1-year membership can be paused for up to 2 weeks, up to six times during a membership.

7.4 **FACILITY RENTALS/BOOKINGS**

a) **Terrace & District Aquatic Centre – Facility Rental Cancellation Policy**

(Including swim meets, private pool bookings, conference room bookings)

- i. User Groups or Renters who provide thirty (30) or more days' notice to their rental/event date to cancel a rental or booking, will receive a full refund to their original payment method or account credit, minus an administration fee.
- ii. User Groups or Renters who provide twenty-nine (29) to fifteen (15) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 25% cancellation fee.
- iii. User Groups or Renters who provide fourteen (14) to seven (7) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 50% cancellation fee.
- iv. User Groups or Renters who provide less than seven (7) days' notice to their rental/event date to cancel a rental or booking, will not receive a refund and will be charged for all fees associated with the rental agreement.
- v. User Groups or Renters who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.

b) **Terrace Sportsplex - Banquet Room and Dry Floor (Hidber and Main Arena)**

- i. User Groups or Renters who provide more than thirty (30) days' notice to their rental/event date to cancel a rental or booking, will receive a full refund to their original payment method or account credit, minus an administration fee.
- ii. User Groups or Renters who provide less than thirty (30) days' but more than fourteen (14) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 25% cancellation fee.
- iii. User Groups or Renters who provide less than fourteen (14) days' but more than seven (7) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 50% cancellation fee.
- iv. User Groups or Renters who provide seven (7) days' notice or less to their rental/event date to cancel a rental or booking, will not receive any refund.
- v. User Groups or Renters who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.

c) **Terrace Sportsplex - Rich McDaniel and Multipurpose Room**

- i. User Groups or Renters who provide more than thirty (30) days' notice to their rental/event date to cancel a rental or booking, will receive a full refund to their original payment method or account credit, minus an administration fee.

- ii. *User Groups or Renters who provide less than thirty (30) days' but more than fourteen (14) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 25% cancellation fee.*
- iii. *User Groups or Renters who provide less than fourteen (14) days' but more than seven (7) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 50% cancellation fee.*
- iv. *User Groups or Renters who provide seven (7) days' notice or less to their rental/event date to cancel a rental or booking, will not receive any refund.*
- v. *User Groups or Renters who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.*

d) Ice Bookings (Renters)

- i. *Renters who provide more than thirty (30) days' notice to their rental/event date to cancel a rental or booking, will receive a full refund to their original payment method or account credit, minus an administration fee.*
- ii. *Renters who provide less than thirty (30) days' but more than fourteen (14) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 25% cancellation fee.*
- iii. *Renters who provide less than fourteen (14) days' but more than seven (7) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 50% cancellation fee.*
- iv. *Renters who provide seven (7) days' notice or less to their rental/event date to cancel a rental or booking, will not receive any refund.*
- v. *Renters who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.*

e) Ice Bookings (User Groups)

- i. *User Groups who provide more than fourteen (14) days' notice to their rental/event date to cancel a rental or booking, will receive a full refund to their original payment method or account credit, minus an administration fee.*
- ii. *User Groups who provide less than fourteen (14) days' but more than seven (7) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 25% cancellation fee.*
- iii. *User Groups who provide seven (7) days' notice or less to their rental/event date to cancel a rental or booking, will not receive any refund.*
- iv. *User Groups who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.*

f) Tournaments / Special on Ice Events

- i. *User Groups or Renters who have booked in for a tournament, or other special on ice event, who provide more than thirty (30) days' notice to their rental/event date*

to cancel a tournament, or other special on ice event, will receive a full refund to their original payment method or account credit, minus an administration fee.

- ii. User Groups or Renters who have booked in for a tournament, or other special on ice event who provide less than thirty (30) days' but more than fourteen (14) days' notice to their rental/event date to cancel a rental or booking, will receive their payment made, minus a 50% cancellation fee.
- iii. User Groups or Renters who have booked in for a tournament or other special on ice event, who provide fourteen (14) days' notice or less to their rental/event date to cancel a tournament or other special on ice event, will not receive any refund.
- iv. User Groups or Renters who fail to attend their rental/booking will not be reimbursed for their payment made and will be charged for all fees associated with the rental agreement.

8.0 ADMINISTRATIVE POLICIES

8.1 CANCELLATIONS OF ACTIVITIES/PROGRAMS

- a) The City of Terrace Parks, Recreation & Culture Department reserves the right to cancel any activity, program, or class due to a lack of registrants, staffing issues, or other issues outside of its control.
- b) Cancelled activities, programs, or classes, will result in full reimbursement to the original payment method or account credit.

8.2 SUSPENSION OR CANCELLATION OF MEMBERSHIPS

- a) The City of Terrace Parks, Recreation & Culture Department reserves the right to suspend or cancel a membership without a refund for inappropriate behaviour or failure to comply with the Facility Code of Conduct as per the City of Terrace Suspension, Banning and Trespass Policy No. 119. These policies are displayed at City facilities and are amended as needed.

8.3 CANCELLATION OF RENTALS/BOOKINGS

- a) The City of Terrace Parks, Recreation & Culture Department reserves the right to cancel rentals or bookings without a refund for inappropriate behaviour or failure to comply with the Facility Code of Conduct as per the City of Terrace Suspension, Banning and Trespass Policy No. 119.
- b) The City of Terrace Parks, Recreation & Culture Department reserves the right to cancel rentals or bookings due to a City of Terrace training event, staffing issues, or other issues outside of its control. Cancelled rentals or bookings will be refunded.

8.4 ADMINISTRATION FEE

- a) The City of Terrace Parks, Recreation & Culture Department reserves the right to charge an administration fee(s) to any bookings that require changes for each instance of change.
- b) Administration fees are set out in Schedule T.

8.5 **DAMAGE DEPOSIT**

- a) *Damage deposits are required when renting the Banquet Room, Rich McDaniel Room, multi-purpose room, the dry floors, the TDAC pool and the TDAC conference room. Following the event, the respective venue will be inspected to determine that there was no damage as a result of the event and/or extra cleanup by staff was required.*
- b) *If no damage or extra clean-up is required, the damage deposit will be returned to the Renter within thirty (30) days. Should the Renter fail to meet the clean-up and closing requirements as per their permit, the damage deposit will not be returned, and additional charges may apply.*
- c) *Damage Deposits are set out in Schedule S.*

8.6 **LATE FEE**

- a) *The City of Terrace Parks, Recreation & Culture Department reserves the right to charge a late fee for any outstanding accounts receivable. That fee will be 2% per month on accounts outstanding on the thirtieth (30th) day following the billing date/due date.*

9.0 **RATE USE CATEGORIES**

9.1 **DEFINITIONS**

- 9.2 **“General Public”** means a one-time event/rental for a group who is not associated or renting on behalf of a registered non-profit organization. The general public rate is the base rate upon which other rate use categories are calculated.
- 9.3 **“General Public Youth”** means a one-time event/rental for a group of primarily individuals under nineteen (19) years of age (over 50%) and who is not associated or renting on behalf of a non-profit organization. The facility rental rate will be 70% of the general public fee.
- 9.4 **“Non-Profit Adult Group”** means a registered non-profit organization that primarily provides services for individuals nineteen (+19) years of age and over. The facility rental rate will be 85% of the general public fee.
- 9.5 **“Non-Profit Youth Group”** means a registered non-profit organization that primarily provides services for individuals under nineteen (19) years of age. The facility rental rate will be 50% of the general public fee. This will include, but is not limited to, the following sports teams and youth program providers:
 - a) Terrace Minor Hockey Association
 - b) Terrace Blueback Swim Club
 - c) Terrace Skating Club
 - d) Terrace Ringette

- 9.6 **“Commercial”** means any individual, company or organization carrying on an activity in City of Terrace facilities for the purpose of generating a profit, excluding not-for profit fundraising. The facility rental rate will be calculated at 115% of the general public fee.
- 9.7 **“Affordable Recreation Access Program”** means persons who are financially disadvantaged and receiving financial assistance from one of the following provincial or federal programs:
- a) Persons with Disabilities (PWD)
 - b) Persons with Persistent and Multiple Barriers (PPMB)
 - c) Regular Income Assistance Benefits
 - d) Canada Pension Plan Disability (CPPD)
 - e) Child Disability Benefit (CDB)

Note: Persons who qualify for the Affordable Recreation Access Program will be required to provide proof of benefits or diagnosis.
