BYLAW NO. 2204 – 2020

“A BYLAW OF THE CITY OF TERRACE TO AMEND BUSINESS LICENCE BYLAW NO. 2112-2016, AND AMENDMENTS THERETO.”

WHEREAS the Municipal Council of the City of Terrace has adopted Business License Bylaw No. 2112-2016, and amendments thereto;

NOW THEREFORE, the Municipal Council of the City of Terrace in open meeting assembled, hereby enacts as follows:

*That the **BUSINESS LICENCE** bylaw is hereby amended as follows:*

1.0 DEFINITIONS

1.1 Add the following definitions in alphabetical order:

***PASSENGER DIRECTED VEHICLE** means a commercial passenger vehicle as defined under the BC Passenger Transportation Act.*

***TRANSPORTATION NETWORK SERVICES** means the use of Passenger Directed Vehicles for the purposes defined in the Passenger Transportation Act.*

2.0 GENERAL

*2.1 Amend Section 21 to read as **TRANSPORTATION NETWORK SERVICES***

21.1 No business license shall be issued by the License Inspector for a Transportation Network Service unless the business has an approval for operating in the Region 5 (North Central and Other Regions) from the Passenger Transportation Board.

21.2 An additional fee, as identified by Schedule “A”, Part II (License Fee Tables) must be paid by every driver operating under the authority of a Transportation Network Service’s Business License.

21.3 All licensing and operating requirements identified under the Passenger Transportation Safety Act must be met for every vehicle and driver operating under the authority of a Transportation Network Service's Business License. (and renumber accordingly).

3.0 SCHEDULES

SCHEDULE "A"; PART II – BUSINESS CLASSIFICATIONS AND LICENCE FEES

3.1 Amend and Add:

78. TRANSPORTATION NETWORK SERVICES means a business that uses Passenger Directed Vehicles for purposes defined in the Passenger Transportation Act.

\$250 for each business.

\$75 for each driver operating as a driver under a TNS.

(re-number other Business Classifications accordingly)

4.0 ENFORCEMENT, OFFENCES, AND PENALTIES

4.1 Amend Section 27.6 to read as:

27.6 This Bylaw may be enforced by means of municipal ticketing information system. Every person who contravenes any provision of this Bylaw or applicable Federal and Provincial Laws or Orders commits an offence and shall be liable on summary conviction to a fine of not less than one hundred dollars (\$100) and not more than ten thousand dollars (\$10,000) and the cost of prosecution.

5.0 APPLICATIONS FOR BUSINESS LICENCES

5.1 Add Section 4.3 to read as:

4.3 The License Inspector may establish terms and conditions that must be met for obtaining, continuing to hold, or renewing a license, including conditions related to:

- (a) safety and security on and about the licensed premises;*
- (b) the protection of minors, including but not limited to conditions regarding signage and patron identification;*

- (c) public health and safety in relation to the licensed premises;*
- (d) prevention of nuisances, including but not limited to conditions intended to reduce noise, odours, and patron misconduct on and about the licensed premises; and*
- (e) requirements that, in the opinion of the License Inspector, are necessary to ensure that the licensed business does not have a negative impact on the public, the neighbourhood or other businesses in the vicinity.*

6.0 This Bylaw may be cited for all purposes, as “Business License Bylaw Amendment 2204 – 2020”.
