2.0 To amend Schedule 'C' (Development Permit Areas) of the Official Community Plan Bylaw No. 2142-2018 by adding the subject land as shown hatched and in bold outline on the accompanying map to Development Permit Area No. 7 – Multi-Family.

To permit the use of the property for medium density multi-family residential land uses such as apartments and townhouses.
